Supplementary Regulations for Race Meeting on 14th September 2008

The Supplementary Regulations for all meetings for the year are on the following pages. The regulations for each meeting will consist of the Club Regulations for that date, the General Supplementary Regulations and the Supplementary Regulations for the venue.

The Rules and Regulations for any meeting will therefore consist of:

- 1 General Supplementary Regulations for all meetings
- 2 Supplementary Regulations for the Venue
- 3 The Club's Supplementary Regulations for the meeting
- 4 Any amendments notified to all entrants
- 5 Final instructions posted on the meeting notice board
- 6 Any amendments done by the Club at the commencement or during the meeting for the better conduct of the meeting or in the interests of safety, such alterations being approved by the Stewards of the Meeting and notified to competitors.

General Supplementary Regulations for all Race Meetings

- 1. The meeting will be governed by APPENDIX 70 MOTORSPORT IRELAND (MI) NATIONAL KART REGULATIONS 2008
- 2. Current Motorsport Ireland competition licence and Registration card or MSA competition licence plus medical certificates and club membership cards must be shown to the Secretary before signing on.
- 3. All karts must comply with Motorsport Ireland regulations and be presented for scrutineering before the time limit set out in these regulations or at any time on request. Protective clothing, boots, gloves and a helmet to Motorsport Ireland Karting Regulations must be worn.
- 4. Competitors not reporting for signing on and/or scrutiny within the time limits set down will either be excluded from racing or allowed to race under penalty and/or fine. Drivers accepted under late entry will only be allowed to race from the back of the grid for all heats.
- There must be a minimum of five entries per class and five starters per race, or that class may be abandoned by the organising club for that event.
 Judges of fact:Judges and Timekeepers named in the official programme or supplementary regulations or final instructions. A Starting Judge to
- observe the start and declare any false starts or other infringements. A Finish Judge to declare the order in which the karts cross the finish line when the end of race signal is given. A Chief Timekeeper to declare the individual lap times and the order in which the karts cross the timing line throughout the competition. A Weighing Scales Judge to record the actual weight of competing karts and report any breach of the minimum weight requirements to the Clerk of the Course. This function may also be performed by a licensed scrutineer. Scales are deemed correct on the day. The onus is on each competitor to check his/her weight. Judge of fact for fuel will be Drennan Fuel Products.
- 7. If a driver's/competitor's transponder fails during a race, no result for that heat/final may be allowed for that race. It is the driver's/competitor's responsibility to ensure that their transponder is securely fixed, charged and fully functional.
- 8. Breech of rules by any driver will be penalised by the Clerk of the Course or the Stewards of the meeting in accordance with the GENERAL COMPETITION RULES.
- 9. Careless, reckless or dangerous driving will be dealt with in accordance with the GENERAL COMPETITION RULES.
- 10. Weights will be strictly enforced for all classes.
- 11. Trophies will be awarded to at least third place in all classes. The number of trophies for each class will be displayed on the meeting notice board.
- 12. Splitting of Grids:In any class in which there are more entries than the maximum grid, there will be a B final (and if necessary a C final) with the first 8 going to the rear of the grid of the A(B) final.
- 13. Driving of Karts in the Pits/Paddock area is strictly forbidden. Any Driver found breaking this regulation will be excluded from racing/results as appropriate. The driving of motorcycles and/or any uninsured vehicle in the Pits/Paddock area is prohibited. Associated drivers will be excluded from racing/results.
- 14. The decisions of the Stewards/Officials of the meeting, on all matters arising out of regulations and racing are final, subject to a right of appeal in accordance with the GENERAL COMPETITION RULES.
- 15. In the event of any driver being adjudged to have made a FALSE START, the Clerk of the Course shall have power to demote the finishing position of any such driver by a minimum five places, in any heat or final, at his absolute discretion.
- 16. Observers and/or Assistant Judges of Fact may be appointed and they will report as appropriate to the Clerk of the Course.
- 17. The club reserves the right to postpone, cancel or abandon the meeting or any part thereof. In the event of any and/or all of the foregoing being implemented, no competitor shall have the right to claim against the club for any loss howsoever caused.
- 18. It is the responsibility of each competitor to make himself/herself aware of all regulations and specifications applicable and to comply with them.
- 19. Flag Marshal's are positioned on the course for the safety of drivers under the direction of the Clerk of the Course. Failure on the part of any driver to immediately comply with Flag instructions may result in the driver being excluded from the race results. Flag signals may be supplemented and/or replaced by light signals.
- 20. Each race should commence after a maximum of two rolling laps. If, on completion of the second rolling lap, the starter is still unable to start the grid, the Clerk of the Course may impose penalties on any driver or drivers up to and including abandoning that particular race.
- 21. Drivers are responsible for the costs of Technical Scrutiny of their equipment.
- 22. In the interests of safety and fair competition, Back Markers who are about to be lapped will be signaled to with a waved Blue Flag. On receiving this signal the driver must give way.
- 23. The Clerk of the Course has the power with the approval of the stewards of the meeting to amend the number of laps.

INDEMNIFICATION: Entry of a kart will only be accepted on condition the Munster Kart Club Limited, Motorsport Ireland, the Sponsors and the Landowners will not, under any circumstances whatever, be liable for any damage to property or injury or loss of whatever kind, sustained by the driver or other persons attending upon the said kart, whether caused during the race or during practice, or while the said kart is on the road forming part of the circuit, or any approach, or on any land adjacent thereto, by whatever means such damage, injury or loss may be caused, and even though the same may be caused by the wilful act, neglect, or default of any official, agent or servant of the Club, Motorsport Ireland, Sponsors or Landowners.
- 7. The Munster Kart Club Limited reserves the right to refuse any entry and/or to debar any kart or driver from competing without assigning a reason.
- 8. ENTRY FORMS: All competitors must read and sign the indemnification on all entry forms. Entry forms must be completed fully and forwarded to the competition secretary together with the entry fee.
- 9. 'General supplementary regulations for all race meetings' and 'Supplementary regulations applicable to the venue for one-day race meetings' form part of these regulations.
